- 八、修習各類學分學程者,務請上網申請修習資格,以利系(院)秘書審查學程學分。未申請 修習學分學程資格而先修課者,亦請上網補辦申請手續。

## 九、 修課注意事項:

## **Descriptions:**

- A. Application time: 09:00AM, Nov 24 to 12:00PM, Nov 28, 2025 (Late applications are not accepted.)
- B. Eligibility (excluding students in suspension of study):
  - a. Applications for Minors and Double Majors:
    - 1. Undergraduates: Students under the  $7^{th}$  Semester (inclusive) of study
    - 2. Graduates: Students under the 2<sup>nd</sup> year (inclusive) of study
  - b. Applications for Credit-Based Programs: Current undergraduate students under the 8<sup>th</sup> Semester (inclusive) of study
- C. Students are allowed to study the Double Major of the same grade or the Minor program of the same grade or one grade lower.
- D. Application procedures: Online application only. Please refer to the following steps: Steps: Go to PU homepage → Select e-Campus, key in personal account name and password. → Select "Minor and Double Major Application" or "Credit-Based Programs Application. New applicants should select "2025/26 2<sup>nd</sup> Semester" as their initial term of study.
- E. To enquire the application results, please go to the "e-Campus" and select "Eportfolio". If there is any error/missing of the information, please apply for correction at the Div. of R&C by Dec 3.
- F. If you've taken Minor or Double Major courses before you're qualified, please contact Div. of R&C to apply for credit ratification (Credit fees may be charged for some courses.)
- G. To apply for "Major/Minor Interchange" or "Changing a Double Major into a Minor", the student needs to renounce the qualification first and re-apply. It's not allowed to take a Minor and a Double Major from the same Department (Division) simultaneously.
- H. The students taking Credit-Based Programs should apply for qualifications online so that the secretary of the Department (College) can review the course credits. Those who take the related courses without application should complete the application procedures online.
- I. Notes:
  - a. In accordance with the Providence University Regulations on Minors and Double Majors, a new applicant must register for a minimum of ONE course in the elected Minor or Double Major curriculum in the initial semester of application (i.e.: the 2025/26 2<sup>nd</sup> Semester). Failed to comply will lead to the disqualification for studying a Minor or Double Major.
  - b. The students who apply for a change or renouncement of Minor/Double Major qualifications should complete their study in the Minor/Double Major program in the 2025/26 1<sup>st</sup> Semester unless they've been approved of a course withdrawal.
  - c. Please refer to the Course Structure Diagram of the respective departments and the related regulations on taking a Minor and Double Major.
